Darin, WA2QOM reminds us that election time is coming up for the new slate of officers. He has appointed a nomination committee composed of K1FUB(chairman), WA7HYD, and N8FV. These appointments received full support from the board. If anyone has any suggestions for nominations, they should be provided to the committee.

The subject of the Handi-Ham QSL bureau was addressed and JR, WU8Q expressed concern that the recent announcement on the reflector about the new bureau leaves out the vision impaired. He suggested that it be announced by net controls on the various nets and any other methods available. It was also suggested that the information be added to the society application as a question regarding their interest in participation in the special bureau. N4JTE advised that he would address the issue with the OMISS Information Officer.

Jeff, K4JRK has appointed the following Net Coordinators: K1FUB for 20m, N8FV for 40m, and AJ1M for 80m. These appointments have all been approved by the board.

N4JTE mentioned that there has been some concern about the maintenance of the information on the website. This is a volunteer effort so let's all be patient.
